The Mayor and City Council met in regular session on Thursday, May 23, 2019 at 6:00 p.m. in the Council Chamber at 10301 Market Street with the following members present: Mayor Diaz, Council Members Rivas, Robinson, Lee, Garcia and Gonzales; City Manager Squyres, City Attorney DeFoyd and City Secretary Raines.

The meeting was opened with Prayer and the Pledge of Allegiance.

A motion was made by Council Member Robinson and seconded by Council Member Rivas to approve the minutes as submitted. Vote: 5 for 0 Against.

DEPARTMENT HEAD REPORTS:

Chief Ayala passed on the Police Department report.

Chief Mier passed on the Fire Department report.

Ivan Rojas, Parks and Recreation Director advised that the Food Bank would be at the gym in the morning because they would be having pre School graduation at Town Center. He stated that the pool would be open this weekend, closed next week and would open for the summer on June 1st and the splash pad was open already.

Elizabeth Flores, Heritage Hall Director advised that all was well at the center.

Israel Savela, Jacinto City Library outline the program and activities they have schedule for the library.

Mayor Diaz advised him that if he needed anything put on the marques to get in touch with Lon or Ivan.

City Manager Squyres advised the Mayor and Council that Harris County would be paving the following street in the city within the next two months: the 100 to 300 blocks of Munn, the 100 to 300 blocks of Chadwick, Sheryl street, Akron from Market to I-10, Hart from Palestine to Lane, Lane from Mercury to Holland, Mercury from I-10 to Market and Perhaps 10200 block of Fairfax and he would get all this to them tomorrow that he had just received it late this afternoon.
