The meeting was opened with Prayer and the Pledge of Allegiance.

DEPARTMENT HEAD REPORTS:

Chief Ayala reminded every one that National Night Out was the first Tuesday in October and if anyone was interested in hosting a party to please contact the police department.

He advised that they had a shooting at 11410 I-10 East and that it was a family problem and they had arrested a sex offender living on Fairfax.

Chief Mier discussed the possible storm that might come our way and cautioned everyone to be prepared just in case. She also reminded everyone that the Market would be on July 13th.

Kyle Reed, Public Works Director, discussed the mosquito problem and advised that they would be spraying.

Ivan Rojas, Park and Recreation Director advised that we would be having movie night in the park on July 19th and movie night at the pool on July 26th and also on the 26th they would have the Food Bank and back to school event with Pct. 2.
