

COUNCIL MEETING, THURSDAY, AUGUST 8, 2019, 6:00 P.M.

The Mayor and City Council met in regular session on Thursday, August 8, 2019 at 6:00 p.m. with the following members present: Mayor Pro Tem Garcia, Council Members Robinson, Lee and Gonzales; City Manager Squyres, City Attorney DeFoyd and City Secretary Raines. Mayor Diaz absent due to work and Council Member Rivas absent due to illness.

The meeting was opened with Prayer and the Pledge of Allegiance.

A motion was made by Council Member Robinson and seconded by Council Member Lee to approve the minuets as presented. Vote: 3 For 0 Against

DEPARTMENT HEAD REPORTS:

Chief Ayala advised that all was going well at PD and it looked like they were getting ready to start on the build out of the lobby and two restrooms.

He also advised that we have had a animal cruelty charge filed in the city.

Chief Mier stated that it was nice and quite in their department and cautioned everyone about the high temperatures we were experiencing and advised them to stay well hydrated. She announced that Market Night would be August 10th, they would have a new food vendor and good music and encourage everyone to come out. She stated the Market had donated a door prize for the North Channel Chamber Luncheon and they were also donating a basket for the North Channel Casino night.

Mayor Pro Tem Garcia thanked them for the door prize they donated to the luncheon.

Ivan Rojas, Parks and Recreation Director, announced that the Food Bank would be at town Center on August 23rd and that it helped a lot of people.

Ivan advised that the pool was doing great, that school started back on August 21st but the pool would be open on weekends through September.

Elizabeth Flores, Heritage Hall Director, stated that they were keeping the seniors busy with activities and trips.

CITY MANAGER’S REPORT:

City Manager Squyres stated that he would be returning part time only and he plan to be at the safety meeting tomorrow.

Mayor Pro Tem Garcia announced that on Saturday August 10th from 10:00 a.m. – 1:00 p.m. at Town Center there would be a Hurricane Harvey Recovery Tour hosted by East Harris County Empowerment Council, Harris County Precinct 2, American Red Cross and CTAB Disaster Relief and went over a list of services that would be provided and what type of information they would need to bring with them.
