COUNCIL MEETING, THURSDAY, JANUARY 12, 2023, 6:00 P.M.

The Mayor and City Council met in regular session on Thursday, January 12, 2023 with the following members present: Mayor Diaz. Council Members Rivas, Robinson, Lee and Gonzales: City Manager Squyres, City Attorney DeFoyd and City Secretary Raines. Council Member Garcia arrived after roll Call.

The meeting was opened with Prayer and the Pledge of Allegiance.

City Manager Squyres stated that at the last meeting we had someone inquire about changing the school crosswalk design, that he had researched this and that was standards governing the crosswalk markings and they had to be in white.

Council Member Rivas ask about making the line and lettering larger and was advised by Mr. Squyres regulations also dictated the size of the lines and wording and he would provide him a copy of this.

Chief Ayala stated that they do check on this and ask what time did he Call.

There was general discussion about gun being used during the holidays and the safety of the officers.

Mayor Diaz stated that it goes on next to her house, it was really bad On Christmas day.

Donna Dailey ask if we had extra officers on duty and was advised that We did.

Council Member Rivas stated that at the last meeting we had a person here concerned about the very tragic incident of the child being run over by one of the private school vans and ask Lon to give an update On efforts to provide laws to regulate this.

City Manager Squyres stated this was going to be called "Isaac's Law" and these private vans were not governed by any regulations, and we had ask State Representative Anna Hernandez and Senator Carol Alvarado to start legislation on this. Representative Hernandez had advised that they would draft legislation like the rules of TXDOT and DPS and it was good that the new law would be passing. He advised that the city was hosting Harris County Mayor's and Council's Association in March we had ask Representative Hernandez to address this legislation.

Donna Dailey ask why the schools can't get with the parents about letting their kids ride these vans.

Ms. Macel ask what about getting with GPISD Superintendent Moore about this.

City Manager Squyres stated that the school district's Attorney governs what they can and can't do, and hopefully we will get this passed at the end of this session and get this taken care of.

Ms. Macal ask if there could be an officer over on Burman at dismissal time and talked about dump trucks going up and down the street.

Chief Ayala and Lt. Longrigg stated they would check it out.


Council Member Gonzales ask Lon what year the city passed a ban on fireworks, that it didn't stop it then, it was still going on.
