Reports of Officers, Employees and Committees:

Chief Ayala advised they were staying busy and they appreciated everything that the community was doing for them. He stated that Detective Walker and other Officers had participated in a drive by surprise for Brice Brown's 6 year old birthday.

He asked that anyone needing their assistance to please call.

Kyle Reed advised that the only thing he had to report was that they went Over the sewer plant with a fine tooth comb this week. Ivan Rojas advised that he had talked with the Food Bank and was told that they were evaluating all the sights that they usually do and would get back with him.

Mayor Diaz advised that the Food Bank cancelled this month.

That we had been having the food bank every month, they cancelled It this month and went to another city and we would try to get it back She discussed other sites they could go to.

Chief Mier advised that they were still getting help from Settrack and they were very grateful, supplies were hard to come by.

Elizabeth Flores Advised that they continue to contact the seniors each day, deliver Meals on Wheels as well as five pack meals to to regular members.

City Manager Squyres advised that a few weeks ago the Federal Government had hired a private corporation to set up a testing site Town Center, they had tested 180 people and 60 came back Comprimized and the Corporation would be calling the 60 people to advise them that they will set up at Town Center on Saturday to retest the 60 at no charge.

He stated that we were anxious to get small business back open and Discussed how this could be done so we would be ready. He stated that We also wanted to be sure the businesses were aware that the Federal Government will provide a grant (which they did not have to repay) to Business owners who pay their employees while they are closed.

He discussed doing court by Zoom and how it would work and that we Were working out the details, that we had already postponed court until May and it looked like we may be later than that and conducting court by Zoom would not be mandatory due to a lot of people not having the equipment to participate.

Mr. Squyres discussed how all the closures, etc. would effect the city; stating that sale tax would be effected due to all the closures but that property tax was already 98% collected.

Ms. Perez stated that since the seniors would not be able to have graduation this year would it be possible to have something for them at Town Center later in the year and they would also like to do a parade to let them drive in their cars.

Mayor Diaz said maybe some time in May, that Lon would talk with the School and we would see what we could do.
