The meeting was opened with Prayer and the Pledge of Allegiance.

DEPARTMENT HEAD REPORTS:

Elizabeth Flores, Heritage Hall, Had no report.

Chief Ayala cautioned everyone to watch out for children now that they were back in school.

Kyle Reed, Public Works Director, stated their department was staying busy keeping the city looking good and they were doing a good job and they would continue to spraying for mosquitoes.

Chief Mier called attention to envelopes that were on the table, stating this was a new program to get rid of expired medications or medication that is no longer being used, you just put them in the envelope, seal it and put it in a mail box, and they go directly to the where they are incinerated and are incinerated unopened at no charge to you. She stated that additional envelopes could be picked up at the fire station if Needed.

Ivan Rojas, Parks and Recreation Department, stated they were staying busy.

2. Council to confirm Magdalena Hernandez as a Jacinto City Police Officer.

Chief Ayala advised that Ms. Hernandez is presently employed With the department in communications and has completed her training to become a police officer, he commended her for accomplishing her goal, that she had been here 3 years and 9 months and was very dependable and he recommends that Council confirm her as a Jacinto City Police Officer.

Ms. Hernandez was accompanied by her Mother, sisters and brother.

Council Member Rivas ask her how long she had been here and she replied that she had lived here all her life.

Council Member Lee ask her if she was born here and she replied she was born in Channelview.

A motion was made by Council Member Robinson and seconded by Council Member Lee to confirm Ms. Hernandez as a Jacinto City Police Officer. Vote: 5 For 0 Against

Mayor Diaz administered the Oath of Office to Ms. Hernandez and presented her with her badge.

Mayor Diaz welcomed Officer Hernandez to the Jacinto City Police Department.

3. Donna Dailey to address the Mayor and Council regarding signs in the city.

Donna Dailey, 1701 Chasen, stated that she was here to address signs located on city property and with all the things going on now we have been very fortunate as long as we remain neutral. She stated that she came here on behalf of PD, that signs in yards was ok, there is an ordinance on that. Political signs, garage signs etc. on city property should not be allowed, they just clutter the city, she thought that political signs was deleted from the ordinance and she thinks all they do is just divide the city, that Jack used to drive around taking down all illegal signs, what has changed.

City Manager Squyres stated that he had signs in the back of his truck now so he still picks up signs. He read from an Ordinance that City Council passed in 1984 and articles from Texas Municipal Law Bulletin and he had discussed this with the City Attorney and he agreed that it would not be easy to do.

He advised that cities could regulate signs based on size but not on based on content.

Donna Dailey stated that she thought we should be able to regulate signs regardless of political, etc.

Dee Maner said she was thankful we had Jim DeFoyd who had been here So long.

Mayor Diaz said it would be up to the Council if they want to pursue this.

Council Member Garcia ask if other cities have this Ordinance.

Dee Maner said maybe ask the politicians to move signs to another area.

Council Member Rivas said things change, he is pretty sure there is some way to say what can and cannot be done on this.

Council Member Robinson said this has been here a long time and he thinks we can do something.

Council Member Lee stated that we can't just do this without some research, we can't violate the law.

Council Member Garcia said if anyone sees them putting out signs where they don't belong, they need to call PD.

Council Member Gonzales said he agreed with everyone but we need to be sure we don't break the law.

Council Member Garcia thanked Kyle for getting rid of the mosquitoes and to call public works and let them know if you are having a mosquito problem so they can spray more. She congratulated Officer Hernandez and that we were glad to have her.

Council Member Gonzales congratulated Office Hernandez, that she would be working for a great police department and cautioned everyone to be safe on Halloween.
