



Public Works Department S.S.O. Pipe Burst Project # 2022-01

The City of Jacinto City proposes the rehabilitation of an estimated 650 linear feet of existing 6" sanitary sewer lines by pipe bursting method.

This project is located at 10500 block of Palestine in the rear easement between Flint & Hart. Pipe burst 650 linear feet of pipe from 6" - 8", reconnect 20 residential sanitary sewer taps, and restore two 6' - 7" deep manholes. Street restoration will be required for one manhole. Additional point repair of 40 linear feet.

Invitation To Bidders**

Sealed Bids, in duplicate, addressed to the Mayor and City Council, City of Jacinto City, Houston, Texas, will be received at the City Hall, 1301 Mercury Street until 5:00 P.M. Thursday, August 25, 2022. BIDS received after closing time will be returned unopened.

BIDS will be submitted in sealed envelopes upon the blank forms provided and marked in the upper left-hand corner "Bid" for reconstruction by pipe burst 6" to 8" sanitary sewer main line to be opened Thursday August 25, 2022, at 6:00 P.M. at Council Meeting

All Bids shall be accompanied by a cashier's or certified check upon a national or state bank in the amount of five percent (5%) of the total maximum bid price payable without recourse to the City of Jacinto City, Houston, Texas, or a bid bond in the same amount from a reliable surety company, as a guarantee that the bidder will enter a Contract. The notice of award of Contract shall be given by the Owner within sixty (60) days the opening of bids. Bid security will be returned to the prospective bidders within ten (10) days after the bids are opened, except those which the Owner elects to hold until the successful bidder has executed the Contract. Thereafter, all remaining securities, including security of successful bidder, will be returned within five (5) days.
