The Mayor and City Council met in regular session on Thursday, August 25, 2022 with the following members present: Mayor Diaz, Council Members Rivas, Robinson, Lee, Garcia and Gonzales; City Manager Squyres and City Attorney DeFoyd. City Secretary absent due to seminar.

The Meeting was opened with Prayer and the Pledge of Allegiance.

A motion was made by Council Member Robinson and seconded by Council Member Garcia to approve the minutes of the previous meeting as presented. Vote: 5 For 0 Against

### **DEPARTMENT HEAD REPORTS:**

Chief Ayala Acknowledged Dee Maner, stating it was nice to see her and her family. He advised that from August 1<sup>st</sup> through August 25<sup>th</sup> the Department had 202 Calls for service and 40 arrests, 1 DWI, 7 drug possessions, 1 unlawful carrying weapon, 2 disorderly conduct, 3 theft, 1 stolen vehicle, 4 traffic arrest, 1 assault and 7 public intoxications and the officer had been busy. He advised that the department was looking for two dispatchers and that Nation Night was October 4<sup>th</sup> and they would be hosting a party at the police station and ask that anyone that would like to host a party to call him.

Chief Mier stated that she had no report at this time.

Ivan Rojas, Parks and Recreation Director's report was not picked up by the sound system.

Elizabeth Flores, Heritage Hall Director's report was not picked up by the sound system.

Was doing and advised that asphalt project was going well and looked good and that T-Construction was working on the wastewater treatment Plant rehabilitation and it was going well. He advised that the mosquito truck would be on the streets, that they were not getting any complaints but that his guys were telling him how bad they were when they were mowing and they had painting the school zones.

Mayor Diaz advised that she had been getting a lot of good comments on the asphalting they were doing.

City Manager Squyres advised that the next three items were virtually the same but have to be dealt with as separate items to meet the federal requirements, they represent a total of \$6,000,000 in grants, EPA Grant – Shelia Jackson Lee just under \$2,000,000, for the Northside, EPA Sylvia Garcia Grant just under \$1,000 000 for the Southside and the ARPA Grant, and they are all very complex. GLO, EPA and HUD are no longer doing environmental on grants, they have passed it down to the recipient which is us. Advertising for (RFP) and (RFQ) are telling the people at large that we are looking for someone to come in to do the environmental submittals and administrative handling of the grants, that small cities can't do this, we will provide them with all the information they need to do the submission to meet Federal requirements which will keep us in compliance,
