DEPARTMENT HEAD REPORTS:

Ivan Rojas, Parks and Recreation Director advised they had approximately 250 people at the Halloween Festival and it was enjoyed by all.

Elizabeth Flores, Heritage Hall Director, stated that tomorrow they would be celebrating Thanksgiving at the center.

Kyle Reed, Public Works Director, Advised that the mosquitos were bad but they had not had any complaints except from his guys who were out mowing, they would have the mosquito truck on the street but they needed complaints from the residents and hopefully the cold that was coming in would take care of them.

Mayor Diaz stated that she only saw 2 lights up on Holland and ask If there was a problem.

Kyle advised that the power company was changing out poles and took our brackets and electric plug with them and wouldn't be putting them back.

2. Amend Budget Code 16-6749 from \$25,000 to \$33,500 for Flock/Raven Audio Detection Device.

City Manager Squyres advised that the original quote was \$25,000 and then there were some dead spot and more had to be added which increased the price to \$33,500 and explained how it worked that the system would narrow gun shots down to the exact location and we were looking forward to this.
