- 3. Council Re-Appointed Gregg Robinson as Mayor Pro Tem for another year due to request from the bank due to the extensive paperwork required at every change.

Motion made by Council Member Rivas to re-appoint Council Member Robinson as Mayor Pro. Tem.

Second was made by Council Member Gonzales.

4. First Reading of Ordinance 2024-1 Setting Salary for Mayor & Council.

Read by City Manager Squyres setting salary rate the same as last year at a rate of:

Mayor: \$400.00 + \$425.00 Auto Allowance

Council Members: \$350.00 + \$425.00 Auto Allowance

Motion was made by Council Member Robinson to keep the same salary rate as last year.

- 5. Economic Alliance Port Houston Region presented their Annual Report to Mayor and Council. Covering their mission which he stated never changes and is "To Grow our Economy", development, Port Houston Activities and Growth over the last 10-15 years, Improvements, and Workforce Development. He also stated that they were able to get a grant approved for Jacinto City from the \$5,000.00 Matching Grant Program and presented the city with a \$5,000.00 check to have two signal boxes painted with good artwork.
- 6. Council to consider approving Variance Board's recommendation for the following addresses: 1502 Belin, 11025 Invierno, 11106 Invierno and 10325 S. Oswego.
  - \* 1502 Belin: Variance requested by Jaime Alvarez to request permission to install a 42' Driveway and cut approximately 17' of curb in order to move his vehicles off of the street and onto his driveway.

    The Current ordinance allows for a maximum of 24'. Public Works and the Building Official has reviewed and have no concerns. A general discussion was held on the matter. The Variance Board Voted in Favor 3/0.

Motion to Approve the Variance Board's recommendation to approve was made by Council Member Gonzales. Second was made by Council Member Robinson.

In Favor: 3/1

\* 11025 Invierno Variance requested by Maria Garcia to request change the zoning from Residential to both Residential and Commercial in order to continue using the house as residential and the existing shed as storage for "Nopalitos Dona Maria". A general discussion was held on the matter. The Variance Board Voted in Favor 3/0. Motion to Approve the Variance Board's recommendation to approve was made by Council Member Rivas. Second was made by Council Member Robinson.

In Favor: 4/0

\* 11106 Invierno Variance requested by Brenda Deleon to request change of zoning for the Residential Lot to Commercial to be able to use as Parking Lot for "Nopalitos Dona Maria". A general discussion was held on the matter. The Variance Board Voted in Favor 3/0.

Motion to Approve the Variance Board's recommendation to approve was made by Council Member Rivas. Second was made by Council Member Robinson.

In Favor: 4/0

\* 10325 S. Oswego Variance requested by Laquesha Hilton to request permission to demolish existing house on a 9,100 sq ft lot and split the lot into 2 lots of 4,550 sq ft each and build a house on each lot. Each house would be 1,100 sq ft and held to the same requirement of distance between each house as all other houses in the city for fire safety's sake. One house would face S. Oswego and the other would face Dacus. Each house would also have their own Driveway. The Current ordinance requires each residential lot to have 5,000 sq ft in order to have a house. The Variance Board Voted in Favor 3/0.

A general discussion was held on the matter in both English and Spanish.

Andrea Rojas, 10341 S Oswego came up to the podium to express concerns regarding safety due to added vehicles that two houses would bring to the street and also because vehicles already go too fast at that corner.

Male resident came up to the podium and expressed concerns regarding preventing vehicle congestion on the street.

Motion to Deny the Variance Board's recommendation to approve was made by Council Member Rivas. There was No Second.

Motion to Approve the Variance Board's recommendation to approve was made by Council Member Robinson. Second was made by Council Member Lee.

In Favor: 3/1

7. Council to confirm Stephanie Ramirez Mendez as Full Time Police Officer.

(She is a young graduate and lives locally. Chief Ayala recommends the city to hire her.)

Motion made by Council Member Rivas to approve Stephanie Ramirez Mendez as Full Time Jacinto City Police Officer.

Second was made by Council Member Lee.
