**e.** Mayor & Council to consider amending Capital Outlay Budget Code 25-6977 by an increase of \$27,000.00 for Emergency Repairs to the City's Water Well.

-Synopsis given by City manager Lon Squyres.

About 3 weeks ago, the motor on our sole water well in the city burned, the fire department had to go and extinguish the large electric motor on top of the well. We just talked about spending about 1.2 million dollars a year buying City of Houston Water, but we're still allowed to pump 20% of our water and it's a lot cheaper to pump our own water, so we need to put that back in order. We are going to accept the lowest bid, which was about 27; it's not at the bid threshold but we bid it out and got about 4 prices and this is going to be the best. We are asking to amend the budget, it's an unexpected expenditure; the pump was at least 25-30 years old so with the council's permission we'll take care of that.
