Minutes

The Mayor and City Council met in Regular Session on
Thursday, August 28, 2025, at 6:00 p.m. in the
Council Chamber at 10301 Market Street.

1. Call to Order: at 6:00 p.m.

- a. Invocation and Pledge of Allegiance:
The meeting was opened with Prayer and the Pledge of Allegiance.
- b. Roll Call:
The following members were present:
Mayor Diaz; Council Members Robinson, Garcia and Gonzales;
City Manager Squyres & City Secretary Rodriguez.
Councilmember Rivas, Lee & City Attorney Defoyd were absent.

2. Mayor & Council Comments:

- *Mayor Diaz & All Councilmembers expressed their well wishes for Happy Labor Day Weekend.*

3. Public Comments:

- *Dan Mims: addressed the Mayor and Council to introduce himself and share that he has made the decision to run for congress, the newly redesigned US District 9.*
- *Eric Sanchez: addressed the Mayor and Council to request installation of stop signs or speed bumps at the intersection of Pilot & Kilroy. He also addressed Mayor & Council regarding personal court cases and concerns with police officers. Mayor Diaz and City Manager Squyres asked Eric to meet with City Manager Squyres after the meeting to schedule a date & time for them three to meet.*

4. Approval of the Minutes of Previous Meeting(s):

5. Reports/Announcements of City Departments:

City: City Manager Lon Squyres

- *We received a notice from CenterPoint that they will be replacing about a hundred poles in the city; primarily south of market, for about the first three or four streets between Switzer and Holland Ave. A few on the north side as well. They are also doing a large project on Baca & I10, be mindful of that for traffic purposes.*
- *The ARPA Water Smart Meter Project is done for all practical purposes. Beginning next week, residents will receive a door-hanger, you can also go to the city website for information on how to get the program on their phone. It helps you prevent having a leak from going on too long. You can set up parameters to alert you when you have a leak so that you can do something about it. The library has also volunteered to help residents set the app up on their phone.*

Heritage Hall: Director Elizabeth Flores

- *No report at this time.*

Parks & Recreation: Director Ivan Rojas

- *Keeping everything nice & clean while keeping the guys hydrated in this heat.*
- *Mayor Diaz noted how good it is to see employees have pride in their work.*

Public Works: Bernardo Perez

- *Department has been busy taking care of water leaks and cutting grass.*
- *Getting Christmas decorations ready.*

Interim Fire Chief, Mo Davis

- The apparatus is here tonight. Interim Chief Davis invited the mayor and council to see the apparatus and go over it with them. The apparatus will be brought back in two weeks, and Interim Chief Davis will show them a new capability on it.
- Being proactive regarding school shootings, the department sent several members to a tactical Shooter, tactical emergency care program and several of us got certified a few weeks ago and with the help of the police department we got some equipment that we needed which was beneficial.
- We were approached by HCC and they are wanting to do a joint effort with us where they would allow their paramedic and fire students to come over to see what we're doing. We're evaluating the pros & cons of that and get with you guys and see if we'll follow thru with that.
- We've had a few fires in the last few weeks. Big thank you to the police department and public works, not only did they help us with the water supply, but they also helped us clean up afterwards, we couldn't have done it by ourselves.
- The water system is very important; when we had fires several years ago, public works would have to spend weeks fixing stuff. This water system that you guys put in for us is phenomenal, it has good pressure, we don't bust mains anymore and it's working great.

Jacinto City Branch Library: Nyla Vela

- All library Fall Programs are on the calendar. Everyone is welcome to pick up program calendars. Events include cooking classes, fun crafts and parties.
- Feel free to send anyone who needs help setting up the water app.
- Mayor Diaz offered to have the library's calendar placed on the city's facebook.

Police: Captain Mark Longrigg

- October 7th is National Night Out. We have reached out to other departments, police departments, to join us. Any organization wanting to be a part of this should contact Chief Ayala. This should be another fun event with comradery, free food and information.

6. Unfinished Business:

- a. Mayor & Council to discuss and take possible action on sealed bids received on August 14, 2025, for the GLO CDBG-MIT No. 22-082-012-D212 Drainage Improvements Project.

Synopsis provided by City Manager Squyres: This was tabled from our last meeting because the bids were very complex. They had to be tabulated compared to one another and the total was about twice the amount of money that was awarded. We were able to isolate the base of the project and then three individual alternates that were included, to come up with a project that was within the dollar amount allocated and yet we felt would be a tremendous benefit to the city and yield a significant reduction in drainage. The way it works is you've got to do it for the whole city. You can't just say, I'm going to go to this area and fix drainage. The projects that we work on must benefit everything or else we don't get the money. The engineers were able to certify that that's going to happen by doing these projects. On the attached page you'll see the two contractors listed. The low bid is MARCON Services, LLC out of Deer Park. Their bid amount for what were asking for was the base plus alternate item one, which is Switzer Street, that's the North South Line on one side of Switzer. We originally wanted to do both sides, alternate three, which is Kilroy Street, which the 300 block floods of Palestine, of Wiggins, of Burman and even some of the further south streets. So that's going to be a tremendous help. And then alternate 6, which is Hart Street. And then there's a few little inlets here and there on top of that. So, the Administration's recommendation is in line with LJA, the engineering, and Grant Works are all asking that the bid go to MARCON Services, LLC in the amount of \$4,394,775.50. and then as a reminder, this is GLO Grant Money. This is not taxpayer money.

7. New Business:

- a. Mayor & Council to Open, Discuss and Take Possible Action on Sealed Bids Received for the 2025 Asphalt Project.

Synopsis provided by City Manager Squyres: We only received one Bid. For those of you that might not be familiar, the city allocates about \$200,000 every year to do a series of small paving projects. Back in the day, you could pave a lot of roadway with \$200,000, not so much nowadays. The Bidder put a copy of the Spec in. This is Trinity Paving and he's over, so we're going to have to value engineer this a little bit. Unless council at another time decides they want to go over it. His Bid is \$250,000. For the sake of time, we'd like to ask council to award this conditionally and let the engineers work it out. There's one of the project Palestine, Mercury, East, they put it \$50,000. We could pull that one section off and put it off until next year. And that would take care of it. So it would be out of this one, three, five and six, it looks like.

- b. Mayor & Council to consider amending capital outlay budget code 33-6798 by an increase of \$2,846.30. for repairs to the wastewater plant's outflow recording system due to lighting strike.

Synopsis provided by City Manager Squyres: At our Sewer Plant, by law, we have to maintain a very accurate digital record of the outflow, how much water we pump out of the sewer plant into Hunting Bayou and there's literally this big wheel, it's a graphic wheel that it records it on and there's a digital wheel as well. That whole system literally fried about a week ago. Lighting hit a tree just outside the Public Works Building, at about that time we checked the graph monitor and that same lightning strike apparently blew out this system. So, we were able to repair one facet of it, but not the charting system, which we're required to maintain by law. So, we're asking to amend that on an emergency basis so that we can make that repair.

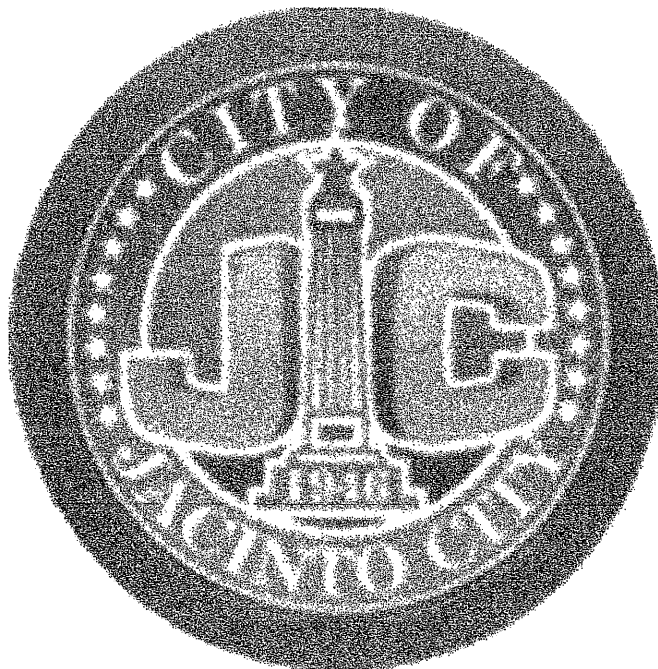
